According to the report The World of Organic Agriculture (2018), India ranked ninth in terms of the size of agricultural land under organic cultivation & has the highest number of organic producers in 2016. Although the country accounts for just 2.59% of the total area of 57.8 million hectares devoted to organic farming globally, India is home to nearly 31 percent of the total organic farmers in the world. But at the same time, most organic farmers are struggling due to the lack of cost-effective & efficient value chains, rising input costs & lack of awareness on scientific cultivation. Organic farming is certainly an effective mode of achieving sustainability, provided farming community, industry, government & all other stakeholders actively participate in sharing the responsibilities & risks to reap the equal benefits & recognition. ASCI facilitates short term training under the flagship schemes of Government of India- Pradhan Mantri Kaushal Vikas Yojana & Rashtriya Krishi Vikas Yojana for capacity building of the farmers & encourage them to take up Organic Agriculture in a big way. Looking at the opportunity of organic products, India has a huge potential in export & domestic markets. The transition to organic farming may take a longer period & appear challenging, but in the long run, it is going to prove remunerative for the farmers & consumers alike. The northeast State Sikkim & many tribal areas of the country in Chhattisgarh, Madhya Pradesh, & Odisha have made significant strides towards organic cultivation. Imperative for skill development in the Organic Sector

he onset of new millennium saw a new India emerging with new opportunities and new challenges. As it is an agriculture driven economy for more than 70% of the population; meeting food demand in a sustainable way is a major challenge. In early 90s sustainable agriculture movement was initiated after the worldwide jeopardy of green revolution. The liberalization of Indian economy in the early 90s meant open market, foreign investment and increased consumerism. Food demand for the exponentially growing population is geometrically increasing whereas, the food production is arithmetically increasing. Due to fragmented land holdings in most parts, it is of utmost importance to empower marginal farmers who form the backbone of the country. Major emerging challenges of Indian agriculture are crop residue management causing air pollution especially in North India, climate change is aggravating droughts, floods, desertification and irregular rain patterns, improper natural resource management, neglected rainfed area, depleting water tables, deteriorating soil ecosystem, deforestation and loss of biodiversity.

There is an upward trend for search of other relatively high paying jobs in turn, creating shortage of agricultural labor leading to increased cost of production. Hence, there is an immediate need to change our approach towards agriculture and its stakeholders.

In order to capacitate the farmers a holistic approach was undertaken by Patanjali Farmer Samriddhi Programme (PFSP) which is being implemented by Patanjali Bio Research Institute (PBRI); supported by Pradhan Mantri Kaushal Vikas Yojana (PMKVY) and NSDC (National Skill Development Corporation) under Ministry of Skill Development and Entrepreneurship (MSDE) in association with ASCI (Agriculture Skill Council of India) to endow skill training for "Organic Grower" and "Group Farming Practitioner".

It was envisaged under the project that awareness of Organic farming would contribute to doubling of farmers' income through an integrated approach under which Farm Labs were established in the farms of selected Trainer Farmers across various agro-climatic zones of the country. State-wise soil profiles were created in order to understand crop-rotations, soil fertility, issues upon adopting organic farming, production costs & profit and finally recommendations for the same. Organic farming practices v/s farmers' practices were experimented; leading to better knowledge dissemination through advertising and skill development to nearby farmers. The major objectives of the programme were to facilitate capacity building by rendering information on potential crops and principles of organic farming, training on better organic package of practices, educating on natural resources management, awareness on cropping systems and mobilizing farmer groups by the trainer farmer.

During implementation of the project significant achievements have been made and valuable lessons learnt. PFSP was able to reach out and train over 42,000 farmers under the job role of organic grower in 18 states of the country covering 178 districts and 348 talukas. Collaboration and linkages were created with various KVKs, SAUs and other institutions for training of the farmers as trainers and for providing technical assistance as per the requirements. The target beneficiaries are farmers interested in Organic Farming from rural areas. Most of the farmers are small and marginal but most of the farmers do have mobile phones which can be used for effective dissemination of agricultural knowledge.

Tangible benefits for Trainer Farmer/candidates: The unique approach of engaging trainer farmers to train the farmers had long term benefits for each category. The trainer farmers underwent a 10 day residential training and certification program. Farm lab units were provided with other essential equipment. Dharti ka Doctor Board and soil testing kit along with trainer handbook and Jaivik Krishi book were are also provided. In the end Job role kit and certificates were handed over as a proof of accomplishment. The farmers were provided with candidate handout and Jaivik Krishi book along with Job role kit and certificate.

Approaches experimented and trends observed: Farmer to Farmer approach has led to establish and strengthen linkages for knowledge sharing, problem solving and mutual appreciation. Trainer certificate provided by ASCI has increased self-esteem and recognition of Trainer

/ Farmers. Farmers are considering self-fulfilling enterprises for e.g. Seed exchange, mutual exchange of products and in a case Factory to Farmer (farmer buying PBRI products) and buy back through seed production (52 tonnes of paddy seed procured) was done.

Suggestions for improvement: Currently, the course curriculum involves theory and practicals however, linkages with stakeholdersis more important and needs more attention. Linkages with departmental functionaries of Agriculture, Horticulture,

Animal Husbandry, Rural development and Panchayat Raj, Krishi Viqyan Kendra (KVK). State Agriculture Universities Agriculture Universities (SAU), Agriculture Research Stations (ARS), reputed NGOs, bankers, financial institutions, Ministry of Micro, Small and Medium Enterprises (MSME), NABARD, representatives of mandis, haats, niche organic markets and urban consumers is necessary. Organizing an event with the above mentioned representatives along with PRI representatives would lead to better understanding and enhance the curriculum for the job role of Organic Grower.
