Message From CEO

Fisheries and Aquaculture is one of the emerging areas that promises to create employment and entrepreneurship opportunities for sustainable livelihoods. The challenge is to ensure that the people working in this sector are appropriately skilled and they have access to latest know-how for increasing production to meet domestic and international demand. While it is important to create the right linkages between the fishermen and the markets, we also need to build capacity through job-specific training that can improve the incomes and empower them with latest techniques to manage post-harvest issues, processing, packaging etc with utmost hygiene to avoid wastage and other losses.

India occupies the second place globally, in Fisheries and Aquaculture, engaging 14 million people. With a total fish production of 10.07 metric tonnes, this sector contributes to 1.1% of GDP and 5.15% of the agricultural GDP. ASCI has embarked on many initiatives to collaborate with education and research institutions, training colleges and other national bodies to create outcome-based curriculum for 26 job roles in Fisheries and Aquaculture. We are also seeking private partnerships to provide training in fishing clusters across India. We are on a mission to expedite blue revolution through skill-based training.

Skill Development in Fisheries Sector - A Catalyst for Blue Revolution in India

Fisheries sector, comprising Aquaculture and Capture Fisheries, has shown a continuous growth of 5 to 6% over the years and there is a dire need for skilling in this sector for doubling the production and farmers' income. Skilled manpower is inevitable as this sector is moving from subsistence farming to commercial activities. Earlier, the fisheries and aquaculture industry was mostly, traditional in nature. In the last two or three decades, a lot of scientific and technical developments have taken place, giving it the commercial status, particularly in Aquaculture where new developments are taking place throughout the world.

In capture fisheries, fishing efforts have increased over the years but fish production has remained almost stagnant over the years. This phenomenon exists throughout the world and in India also. On the other hand, we need to produce more fish to meet the increasing demand for human consumption, as fish is fast becoming a healthy alternative and a cheap source of protein for many. However, production from the traditional fishing practices, in terms of capture fisheries remains the same and hence there is a need for increasing the fish production mainly through farming practices called Aquaculture.

Top job roles for skilling in Fisheries and Aquaculture sector

In the changing scenario of fisheries and aquaculture, ASCI has identified 26 job roles in consultation with industry and institutions. In Aquaculture, we have job roles such as Aquaculture Technician, Aquaculture Worker, Freshwater Aquaculture Farmer, Hatchery Manager, Hatchery Production worker, Fish seed grower, Brackishwater Aquaculture Farmer, Shrimp Farmer, Feed Technician, Aquarium Technician, Mariculture Operator, etc. In Capture Fisheries, we have job roles like Marine fisherman, Inland fisherman, Fishing Boat Driver, Fishing Boat Deckhand, Fishing Boat Maintenance Worker, Fishing Boat Mechanic and other support services.

Challenges

It is a challenge to change the mindset of the Institutions and capacity building providers to bring them to do a skill-based training program. As of now, they indulge mostly in knowledge-based, theoretical learning with minimum focus on skills. Most of the institutions lack quality trainers, infrastructure and environment for long-term skill-based training. We are planning to take help from the industry and private sector for this purpose. We are in the process of identifying potential training partners, training the trainers, master trainers, curriculum and content development, etc. to speed up skilling programmes in fisheries sector to meet the skilled manpower requirement.



Entrepreneurship opportunities

There are lot of entrepreneurship opportunities in the emerging Aquaculture sector, though in initial stages. However, entrepreneurship development requires a push from the government and other institutions and it is encouraging to see some incubation centers coming up in this sector since the last five years. Though there is provision for technical support from the industry, we need financial support to sustain incubation of startups and help them accelerate and grow. When it comes to handling risks in this sector, if the business becomes sustainable, the risks get mitigated. Unlike what happened to Shrimp Farming in the 1990s with the occurrence of diseases, leading a setback to investments, inland aquaculture has remained sustainable over many decades. Nevertheless, they need insurance coverage since they are prone to losses during natural calamities like floods and cyclones.

Skilling as a catalyst for Blue Revolution

The major aim for skill development in agriculture and allied sectors is to double the farmers' income by doubling the production. In fisheries sector, Government of India has implemented the Blue Revolution Scheme, a flagship programme to increase the fish production to 15 MMT by 2020. Out of India's production of 10 million metric tonnes, marine fisheries contribute around 3 to 4 million metric tonnes. It cannot be stretched much, as our potential is only 4.5 million metric tonnes by exploiting 80% of the resources. So, doubling the production is not possible through marine fisheries.

As per this year's budget, Government has provided an outlay of Rs 10,000 crores for National Fisheries and Aquaculture Infrastructure Development Scheme mainly for developing the infrastructure and environment for the sustainable development in this sector with multistakeholder involvement. Skill development forms a crucial part of the scheme to take forward the initiatives of increasing the fish production and improving the farmer's income.

Engagement with Ministry of Agriculture

→ Skilling under Rashtriya Krishi Vikas Yojana (RKVY)

Skilling through RKVY has positive impact on rural youth and farmers. A total of 450 Institutes were selected to implement 882 skill training program during 2018-19. A total of 15,615 farmers and rural youth have already been skilled during 2018-19. Courses like Mushroom Grower, Vermicompost Producer, Small Poultry farmer and Dairy Farmer/Entrepreneur were popular among farmers. More than 40 percent of farmers have chosen these job roles for the training. There are 51 job roles under which skilling have been imparted.

To streamline this training under RKVY and aligning with NSQF, ASCI conducted various Training of Trainer (ToT) program across India to conduct assessment and certification of trainers. A total of 747 trainers got certified in 11 ToTs under RKVY.

Skilling under Mission of Integrated Development of Horticulture (MIDH)

The Centrally Sponsored Scheme of MIDH which integrates the ongoing schemes of National Horticulture Mission, Horticulture Mission for North East & Himalayan States, National Bamboo Mission, National Horticulture Board, Coconut Development Board and Central Institute for Horticulture, Nagaland also joined the skill ecosystem. In this fiscal, over 3,336 candidates have been trained and certified across the country under Amenity and Production Horticulture.

Key Initiatives



Stakeholder Meeting at Gurugram

ASCI organized a Stakeholders Meeting focused on Equine and Small Captive Animal Management segment on 14th Jan'19 wherein experts from the Remount Veterinary Services (RVS), National Academy of Veterinary Services (NAVS), Brooke India and other organizations participated and contributed in identifying the skills, knowledge & competencies required for the 6 new Job Roles under development. Discussions revolved around 9 Job Roles Viz. Equine Breeder, Equine Rider & Trainer, Equine Farrier, Equine Groom, Canine Breeder, Canine Trainer, Companion Animal Groomer, Stray Animal Catcher and Zoo Animal Keeper.
